- (1) 有關《個人資料(私隱)條例》(第486章)的須知 Notes Regarding the Personal Data (Privacy) Ordinance (Cap. 486)

(2) 申請人須將填妥的持牌處所改建申請表送交康樂及文化事務署。
The applicant shall complete the Application for Alteration to Licensed Premises and submit it to the Leisure and Cultural Services Department.

(3) 申請表須連同有關處所的擬議設計圖則(圖則無須標示可移動家具,例如不固定安裝的枱及椅子)一式五份一併遞交, 否則本署無法處理有關申請。前述圖則須以十進制單位和不少於1:100的常用比例繪製,並清楚繪示該場所內須領牌的 各部分。

The application must be accompanied by 5 identical hard copies of the proposed layout plans of the premises (Movable furniture, such as non-fixed tables and chairs, are not required to be shown in the plan), otherwise this department is unable to process the application. The aforesaid plans must be drawn in metric unit and in scale commonly used of not less than 1:100, showing clearly the various parts of the place for which the licence is required.

(4) 如牽涉通風系統(包括空氣調節系統)的改動,申請人須安排把通風系統最終安裝在場所內的設計,盡量按照比例繪畫在通風系統設計圖則上,然後把圖則一式三份一併遞交。

In case that a ventilating system (including an air-conditioning system) is to be altered, the applicant is required to submit the ventilating system layout plans in triplicate, drawn as nearly as possible to scale, showing the final layout of the ventilating system to be installed in the place.
