申請人須知 Notes to Applicants

- (1) 有關《個人資料(私隱)條例》(第486章)的須知 Notes Regarding the Personal Data (Privacy) Ordinance (Cap. 486)
 - (a) 收集資料的目的 Purposes of Collection

經這份申請表填報的個人資料,將由發牌當局用於下列用途: The personal data provided by means of this form will be used by the Licensing Authority for the following purposes:

- (i) 處理向發牌當局申請簽發遊樂場所牌照的相關事宜;以及 carrying out activities relating to the applications for the grant of Places of Amusement Licence made to the Licensing Authority; and
- (ii) 方便發牌當局職員和其他政府部門的職員與申請人聯絡。 facilitating communication among staff of the Licensing Authority, other government departments and the applicant.

申請人透過本申請表提供個人資料,純屬自願。不過,若申請人未能提供足夠的資料,則發牌當局可能無法處理有關牌照的申請。

The provision of personal data by means of this form is voluntary. However, if the applicant fails to provide sufficient information, the Licensing Authority may not be able to process the application of the licence.

(b) 獲轉授資料的機構類別 Types of Transferees Receiving the Data

在本申請表填報的資料可能會被轉交其他政府部門和機構,以達致上文第1段所載的目的。這些個人資料亦會向其他政府部門披露以作執法用途。

The personal data provided in this form may be disclosed to other government departments and agencies in pursuance of the purposes mentioned in paragraph 1 above. The personal data may also be disclosed to other government departments for law enforcement purposes.

(c) 查閱個人資料 Access to Personal Data

根據《個人資料(私隱)條例》(第486章)第18條、第22條及附表1第6原則的規定,申請人有權要求查閱和更改 所提供的個人資料。查閱的權利包括有權索取在本申請表內所填報的個人資料副本乙份。 Applicants have the right of access to and correction of the personal data provided in accordance with Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Cap. 486). The right of access includes the right to obtain a copy of the personal data provided in this form.
